GENERAL

: Unless emphatic mentioned otherwise and or mentioned otherwise in quotations the following conditions apply to all our offers, supplies and services.

EXPORT

: GENERAL CONDITIONS FOR THE SUPPLY OF MECHANICAL, ELECTRICAL AND ELECTRONIC PRODUCTS ORGALIME SE 01, filed by ORGALIME – LATEST EDITION.

PRICES

: Prices mentioned in offers and price lists are per unit rate. (Unless mentioned otherwise).

DEDUCTIONS

: Possible deductions which will be granted are given on the condition that payment takes place within the agreed time period.

RUSH ORDERS

: Normally rushorders will be ready within 5 production days to sent or collect them (unless otherwise agreed).
Herewith all deductions will expire (unless otherwise agreed).

ORDER COSTS

: Nett amount up and to EUR 150,-- (exclusive material- or other charges and eventually taxes) will be charged with EUR 15,-- as part of the handling costs, unless otherwise agreed.

MATERIAL SURCHARGE

: A material surcharge may be added to prices and this will be determined on the day of ordering. This surcharging relates to copperwire and/or copperfoil and/or transformercore.

TAXES

: Prices are exclusive, of the V.A.T. Percentage applicable at the time of delivery. At export all our prices are exclusive any import duties, abroad taxes etc.

PACKING

: Included, if necessary on (loan) pallets of our choice. (Unless mentioned otherwise). Products with a (joint) weight to 30 kgs. in cardboard boxes, bigger weight on pallets. DHL is owner of pallets and , these will be collect within 5 working days. See also the "Poolvoorwaarden" at the backside of the "palletbon".

DAMAGE

: During receive of damaged goods and/or packings you must follow-up the instructions mentioned on the delivery-note. In case you ignore these instructions we cannot guarantee eventually free repair or (re)-delivery.

FREIGHT COSTS

: Prices are for FREIGHT CHARGED ON INVOICE delivery for Dutch destinations, not unloaded, provided dispatching agent is of our choice (unless mentioned otherwise). For destinations outside The Netherlands EX WORKS. (Unless otherwise mentioned in quotation). The condition FRR or also Free at site – Freight on invoice means that Trafa takes care of the transport, prepaid and eventually charges. The cost of transport will be lower if Trafa arrange this matter because:
A) Trafa has fixed price agreements with a groupage-expeditor
B) Trafa gathers there where is possible the goods to send them in one (week) shipment.

PAYMENT

: Within 30 days after invoice date strictly net.

VALIDITY

: At announced price changes the in your possession pricelists expire at the day of modification. Offers are valid for up to 2 months after date of quotation. Any material surcharges included are valid for up to 1 week after date of quotation.
